A table of documents and their respective "points" value to assist notaries in proving the identities of persons requiring notarial services

#### **NOTES**

The table of documents and their respective "points" value has been prepared to assist notaries in proving the identities of persons requiring notarial services.

The "points" value of acceptable documents which are produced must add up to at least 100 points.

If a document is in a language other than English and if the notary is not literate in that language, the document must be accompanied by:

- a sworn translation into English by a NAATI accredited translator; or
- a certified translation by a consular officer of the embassy or consular post in Australia of the country in which the foreign language document originated.

If any document produced is in a person's previous name, the person must produce additional documentation, including translations where necessary, showing how his or her name was changed, e.g. a marriage certificate or a deed poll. *Documents produced to evidence name changes do not count towards the "100 points"*.

Copies of documents on "smart" devices are increasingly commonly produced for I.D purposes. Only original unaltered documents are acceptable.

Official government "digital" documents such as digital driver licences are in acceptable form, but should first be authenticated in the manner prescribed by the issuing government department or entity.

Australian Defence Force Identity Card in the person's name/former name	70
Shooter's or Firearm Licence	
Current shooter's or firearm licence showing signature and photograph and the person's present name	70
Security Licence	
Current security protection industry or crowd control licence showing signature and photograph and the person's name <b>Australian Birth Certificate</b>	70
Australian birth certificate in the person's name/former name issued and certified by a state or territory Registrar of Births Deaths and Marriages	40
Bank Statement or Passbook	
Current passbook or recent statement for current credit card/ATM card or cheque account at financial institution showing the person's name and current address	40

Current credit card/ATM card with financial institution showing the person's signature	40
Driver's Licence - Motor Vehicle	
Current state or territory issued driver's licence, learner's permit or provisional licence showing signature and/or photograph and the person's name and current address	40
Decree Nisi	
Australian Divorce papers in the person's name/former name	40
Defence Force Discharge Papers	
Australian Defence Force discharge papers, in the person's name/former name	40
Educational Certificate	
School/educational certificate in the person's name/former name (School/TAFE/University)	40
Australian Marriage Certificate	
Australian marriage certificate issued and certified by a state or territory Registrar of Births Deaths and Marriages.	40
Name Change	
State or territory official change of name certificate or deed poll certificate	40
Proof of Age Card	
Current proof of age card issued by a government agency in the person's name with photograph and/or signature	40
Registration Certificate from Professional Board	
Registration certificate from a national or state/territory professional organisation board, e.g. doctors, nurses, dentists, physiotherapists, accountants	40

Current student ID card issued in the person's name with signature and/or photograph (School/TAFE/University)	40

Current Australian trade certificate in the person's name/former name	40
Veteran's Affairs Gold Card	
Current Department of Veteran's Affairs Gold Card issued in the person's name	40
Reference from Indigenous Persons Organisation	
Reference from an Aboriginal/Torres Strait Islander organisation showing referee's full details and length of time the referee has known the person. <i>To be verified with the organisation</i>	20
<b>Educational Report or Reference</b>	
School/education reports or references, including enrolment confirmations, in the person's name/former name. <i>To be verified with the organisation (School/TAFE/University)</i> .	20
PAYG Payment Summary (Group Certificate)	
Recent PAYG payment summary or group certificate, not more than two years old, with tax file number. <i>To be verified with employer</i>	20
Insurance Renewal	
Recent insurance for house, contents, car, boat, crop insurance in the person's name and showing current address  Tenancy Agreement or Lease	20
Recent formal tenancy agreement or lease in the person's name and showing current address	20
Medicare Card	
A Medicare card showing the person's name	20
Motor Vehicle Registration	
Current motor vehicle registration showing the person's name and current address and proof of payment	20

## **Other Licence**

Any other current Commonwealth, state or territory licence for coxswain, boat, heavy vehicle, aircraft etc. <i>Must have the person's photograph and/or signature</i>	20
Rates Notice	
Recent rates notice in the person's name and showing current address and proof of payment	20
Utility Account	
Recent utility account, e.g. gas, water, electricity or telephone in the person's name and showing current address and proof of payment	20
Share Certificate	
Share Certificate issued in the person's name	10
Electoral Enrolment	
Proof of electoral enrolment card issued in the person's name and current address	10
Other Financial Documents	
Other financial documents such as superannuation statements, life insurance, term deposits issued in the person's name, not more than 12 months old. <i>Not a hire purchase or lease agreement</i> .	10
Health Insurance Card	
Current health insurance card showing the person's name	10
Motoring Association Card Membership	
Current membership card or documents issued in the person's name: NRMA, RACQ, RACV, RAA, RACT, RAC(WA), AANT	10
Taxation Notice of Assessment	
Recent taxation notice of assessment in the person's name less than two years old	10
Employment Records	
Termination notice, separation certificate, report or reference from employer in the person's name. <i>To be verified with employer</i> .	10
